Submission Deadline for Priority Processing: April 23, 2021

If you enroll your student in a private school **before** you have received a **SCHOLARSHIP AWARD LETTER** and **School Commitment Form (SCF)**, you will be responsible for your student's tuition and he/she may not qualify for future scholarship funding. Funding is not guaranteed. Please consider this before enrolling your student(s) in a private school.

ARE YOU ELIGIBLE TO SUBMIT AN APPLICATION? COMPLETE THE QUESTIONS BELOW TO FIND OUT.

- 1) Does the household live in Georgia?
 - Yes, we live in Georgia. **Please continue to question #2.**
 - No, we live in another state. **STOP** – do not apply; your household is NOT eligible to submit an application.
- 2.) Did your student have a Georgia scholarship from AAA during the 2020-2021 school year?
 - Yes, my student had a Georgia scholarship from AAA during the 2020-2021 school year. **Please continue to question #3.**
 - No, my student didn't have a Georgia scholarship from AAA during the 2020-2021 school year. **STOP** – do not apply; your household is NOT eligible to submit an application.
- 3) Will your student be between the required ages to attend school for your state on or before September 1, 2021?
 - Yes, my Georgia student will be at least 4 years old but not 21 years old or older on September 1, 2021. **Please continue to question #4.**
 - No, my student will not meet the age requirements for my state. **STOP** – do not apply; your student does not qualify to receive a 2021-22 AAA scholarship.
- 4) Is your student entering Pre-K4 through 1st grade in Georgia?
 - Yes, my student is entering Pre-K4 through 1st grade in Georgia. **Please continue to question #6.**
 - No, my student is entering 2nd through 12th grade in Georgia. **Please continue to question #5.**
 - No, my student will NOT be entering those grades. **STOP** – do not apply, your student does not qualify to receive a 2021-22 AAA scholarship.
- 5) AAA considers ALL household members and their income. To figure out your household size, count all the people you live with together. Next, add-up ALL the monies earned/received* (taxable and non-taxable) by everyone in the household during 2020; this is your total annual income. Use these two numbers to find the maximum annual income allowed in the chart below.
