

## Arizona Tax Credit Scholarship Program – Insurance Premium Tax

Through the Arizona Corporate Tax Credit Scholarship Program, your company can redirect up to 100 percent of its state insurance premium tax liability to the AAA Scholarship Foundation (AAA) so that we can fund K-12th grade scholarships for children to attend the school that best meets their educational needs – and your company will get a dollar-for-dollar tax credit.

\* It's important to remember that the approval process does not oblige you to remit the funds to AAA – it is merely a way for the DOR to ensure that the annual maximum in tax credits is not oversubscribed.

### When can I apply?

We are currently accepting tax credit applications for 2023 tax credits. Each annual Arizona tax credit application season ("cap year") opens on the first business day of July. The cap year will end when all of the credits are claimed, or the following June 30th, whichever occurs first. Please contact our office for a tax credit application.

### How much is available?

#### 2024-25 Cap Year

Approx. \$161.7 Million\* available for the Low-Income Tax Credit Scholarship Program

**\$6 Million** available for the Disabled/Displaced Tax Credit Scholarship Program \*Subject to change – amount is projected. Set amount will be released by the Arizona DOR in the spring of 2024.

# **Unused Credits?**

If your company determines that you have insufficient tax liability to take the full credit (amount remitted is greater than 100 percent of net tax liability), it may carry the credit forward for up to five years.
